NATIONAL GRAND PRIZE OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. The Barrett-Jackson Fantasy Bid Game (the “**Game**”) may only be entered in or from the fifty (50) United States and Canada (excluding the province of Quebec).

The Barrett-Jackson Fantasy Bid Game is a game of skill.

NOTE: In order to claim any prize in this Game, you must have registered on the promotion site including the completion of all required input fields, including, but not limited to the registrant’s legal name and valid email address prior to the start of a Game auction. You may play as a guest, but you will not receive a Prize for any accumulated overall points you may have achieved.

1. **GAME DESCRIPTION:** The Sponsor of this Game is Barrett-Jackson Auction Company, LLC located at 15555 North 79th Place, Suite A, Scottsdale, AZ 85260 (the “**Sponsor**”). The Fantasy Bid Game will consist of a fantasy bid game, that includes predictive questions, whereby entrants will be given the opportunity to build points. The objective of this Game is to earn as many points as possible by participating in all Game auctions. The participant with the greatest number of accumulated points at the end of the four (4) Game auctions, will be the grand prize winner (“**Grand Prize Winner**”). There will be one (1) Grand Prize winner announced on or about Monday, September 14, 2026. Grand Prize will be awarded to the registered entrant with the greatest accumulated points over the four (4) Game periods (each a “**Game Period**”)
2. **GAME TIMING:** The Game Period 1 entry period begins on Friday, January 2, 2026 and ends Saturday, January 24, 2026 at 11:00 a.m. Eastern Time (the “**Game Period**”). A leaderboard will be updated live during each of the four (4) auctions (Scottsdale, AZ; Palm Beach, FL; Columbus, OH; and Las Vegas, NV). By participating, each Entrant (as defined below) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and legally binding in all respects.
3. **ELIGIBILITY:** The Game is open only to legal residents of the fifty (50) United States, including the District of Columbia and Canada (excluding the province of Quebec), who have **not won** in any previously conducted Fantasy Bid Game,

sponsored by Barrett-Jackson Auctions, LLC, who are at least 18 years of age or the age of majority in the state/province the entrant resides, whichever is older at the time of entry, and who have received eligible Game Points in their registered account during the Game Period (the “**Entrant**”). Employees, officers and directors of Sponsor, STELLANTIS N.V., and any participating promotional partners, and each of their respective parent companies, subsidiaries, affiliates, partners, dealers, advertising and promotion agencies, manufacturers or distributors of promotion materials (all such individuals and entities collectively referred to herein as the (“**Promotion Entities**”) and each of their immediate family members (parents, children, siblings, spouse) and/or people living in the same household (whether related or not) of such employees/officers/directors are not eligible to enter the Game or win a prize. LIMIT: One (1) Game registration per person only.
